RESOLUTION APPROVING APPOINTMENT OF PAIK, BREWSTER & DEAL TO PROVIDE TRIBAL PROSECUTORIAL SERVICES

WHEREAS, the Mashpee Wampanoag Tribe ("Tribe") is a federally-recognized Indian tribe with a duly-enacted Constitution;

WHEREAS, the Mashpee Wampanoag Tribal Council ("Tribal Council"), the governing body of the Tribe, deems it essential under Article VI, § 2.A. of the Mashpee Wampanoag Tribal Constitution ("Constitution") to promote and protect the political integrity, economic security and general welfare of the Tribe and members of the Tribe;

WHEREAS, Article VI, § 2.D. of the Constitution empowers the Tribal Council to negotiate and enter into contracts and agreements with state and local governments, private persons and corporate entities;

WHEREAS, the Tribal Council desires to appoint attorney Young Paik of Paik, Brewster & Deal as Tribal Prosecutor to assist the Tribe with criminal matters heard before the Tribal Court; and

WHEREAS, the Tribal Council has requested that Paik, Brewster & Deal implement an ethical firewall to ensure all criminal matters remain separate and confidential from any other legal matters handled by the firm; and

WHEREAS, the Tribal Council desires to approve and authorize the appointment of Young Paik of Paik, Brewster & Deal as a Mashpee Wampanoag Tribal Prosecutor in connection with criminal matters heard before Tribal Court; and

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Council approves and authorizes the appointment of Young Paik of Paik, Brewster & Deal as a Mashpee Wampanoag Tribal Prosecutor in connection with criminal matters heard before Tribal Court.


