ACKNOWLEDGEMENT OF CITIZEN PARTICIPATION IN COMPLIANCE WITH HUD NOTICE PIH-2021-22

WHEREAS, the Mashpee Wampanoag Tribe (“Tribe”) is a federally-recognized Indian tribe with a duly-enacted Constitution;

WHEREAS, the Mashpee Wampanoag Tribal Council (“Tribal Council”), the governing body of the Tribe, deems it essential under Article VI, § 2.A. of the Mashpee Wampanoag Tribal Constitution (“Constitution”) to promote and protect the political integrity, economic security and general welfare of the Tribe and members of the Tribe;

WHEREAS, Article VI, § 2.D. of the Constitution empowers the Tribal Council to negotiate and enter into contracts and agreements with state and local governments, private persons and corporate entities;

WHEREAS, HUD awarded the Tribe, by and through its Housing Department, an award of \$1,035,000.00 for purposes of addressing the homeless crisis caused by the pandemic COVID 19 (“ICDBG-ARP award”);

WHEREAS, HUD requires that all applicants, pursuant to applicable requirements and, in particular Notice PIH-2021-22, meet the citizen participation requirements by publishing and posting information on their proposed plans to use the ICDBG-ARP award and accepting and considering comments;

WHEREAS, on February 24, 2022, the Tribe scheduled a meeting for the Tribal community for purposes of providing information and seeking comments in connection with the ICDBG-ARP award (the “Citizen Participation Meeting”);

WHEREAS, Tribal citizens participated in the meeting and submitted written comments that were accepted and submitted;

WHEREAS, the Citizen Participation Meeting was duly noticed and published on the Tribe’s website and held in compliance with applicable HUD requirements.

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Council hereby acknowledges that the Citizen Participation Meeting was duly held for purposes of informing the Tribal community of the ICDBG-ARP award and seeking comments in compliance with applicable HUD requirements.

BE IT FINALLY RESOLVED, that the Tribal Council hereby grants to the Tribal Chairman, or in his absence, other Officer of the Tribal Council, the requisite authority and power for an on behalf of the Tribe to take such further action necessary to effect the purposes and acknowledgement of this Resolution.

All resolutions or parts of resolutions inconsistent with this resolution are repealed. This resolution is effective immediately and shall continue pursuant to the authority vested in the Tribal Council pursuant to Article VI, §§ 2.A. and D. of the Constitution.


