**RESOLUTION APPROVING ANNUAL TRIBAL COUNCIL REGULAR MEETING  
CALENDAR 2024**

**WHEREAS,** the Mashpee Wampanoag Tribe (“Tribe”) is a federally-recognized Indian tribe with a duly-enacted Constitution; and

**WHEREAS,** the Mashpee Wampanoag Tribal Council (“Tribal Council”), the governing body of the Tribe, deems it essential under Article VI, § 2.A. of the Mashpee Wampanoag Tribal Constitution (“Constitution”) to promote and protect the political integrity, economic security and general welfare of the Tribe and members of the Tribe; and

**WHEREAS,** Article IX, § 1.A of the Constitution requires the Tribal Council to meet in official session at least once a month at such time and place as shall be established by ordinance; and

**WHEREAS,** the Tribal Council desires to adopt a Tribal Council Regular Meeting Calendar for the year 2024 (the “Tribal Council 2024 Calendar”) that sets the time, place and date of Tribal Council meetings attached hereto as Exhibit A; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Tribal Council hereby approves the Tribal Council Regular Meeting Calendar for the year 2024 as attached hereto.

**BE IT FURTHER RESOLVED,** that the Tribal Council shall meet in accordance with the Tribal Council 2024 Calendar unless cancelled for lack of quorum or due to other unforeseen circumstances.



**BE IT FINALLY RESOLVED**, that the Tribal Council retains the authority under Tribal Law to schedule any additional regular, special or emergency meetings properly called and held with a quorum in attendance should future needs arise.

Effective immediately and until revoked or modified by the Tribal Council, pursuant to the authority vested in the Tribal Council pursuant to Article VI, Sections 2.A. and D. of the Constitution of the Mashpee Wampanoag Tribe.


All resolutions or parts of resolutions inconsistent with this resolution are repealed. This resolution is effective immediately and shall continue pursuant to the authority vested in the Tribal Council pursuant to Article VI, §§ 2.A. and D. of the Constitution




**CERTIFICATION**
