TRIBAL COUNCIL RESOLUTION
2023-RES-098
APPROVAL AND AUTHORIZATION OF USET TRIBAL MEMBERSHIP

WHEREAS, the Mashpee Wampanoag Tribe (“Tribe”) is a federally-recognized Indian Tribe with a duly-enacted Constitution; *and*,

WHEREAS, the Mashpee Wampanoag Tribal Council (“Tribal Council”), the governing body of the Tribe, deems it essential, and is empowered, under Article VI, §2.A. of the Mashpee Wampanoag Tribal Constitution to promote and protect the health and general welfare of the members of the Tribe; *and*,

WHEREAS, the Tribal Council is aware of the United Southern and Eastern Tribes, Inc. (“USET”) which is a non-profit, intertribal organization that collectively represents its member Tribes at the regional and national level; *and*,


WHEREAS, the Mashpee Wampanoag Tribe wishes to continue its membership with USET and deems it in the best interest of the Tribe to continue participating in this organization; *and*;

NOW, THEREFORE BE IT RESOLVED that the Mashpee Wampanoag Tribal Council, which is the official governing body of the Tribe, hereby authorizes Tribal Council Chairman, Brian Weeden, who is the official principal tribal official, to take the necessary action to ensure the Tribe’s Membership with USET; *and*,


BE IT FURTHER RESOLVED that Tribal funds in the amount of \$500 for the “General Support” and “Yearly” membership dues for USET; *and*,

BE IT FURTHER RESOLVED that the Tribe designates the following persons as USET Board Member and Alternate USET Board Members to represent the Tribe at USET:

Effective immediately and until revoked or modified by the Tribal Council, pursuant to the authority vested in the Tribal Council pursuant to Article VI, Section 2.A of the Constitution of the Mashpee Wampanoag. All resolutions or parts of resolutions inconsistent with this resolution are repealed.

We, the undersigned Chairperson and Secretary of the Mashpee Wampanoag Tribal Council do hereby certify that the Tribal Council is composed of 13 members of whom 11, constituting a quorum, were present at a meeting thereof, duly and regularly called, noticed, convened, and held on the 20th day of September 2023, and that the foregoing Resolution was duly adopted by the affirmative vote of 10 members, with 0 opposing, and with 0 not voting.
