Chairman's Column ———



Greetings Tribal family,

There's been a tremendous amount of great work that's taken place at our Tribal Community and Government Center over the past few weeks. I'd like to highlight a few of them in my column that stood out for various reasons.

Last month we made great progress with the Town of Mashpee to further strengthen our government-to-government relationship. Also, our Powwow Committee has been working tirelessly to organize the traditional home coming of our powwow. Our Housing Department is now accepting housing applications for the initial phase (42 units) of our Meetinghouse Road Housing Development. Finally our tribal body approved our annual operating budget at the May 20 General Membership Meeting.

I want to first talk about the initial work I highlighted above regarding recent actions taken by the Town of Mashpee and their unequivocal support of the Mashpee Wampanoag Reservation Reaffirmation Act and its swift passage.

At their regularly scheduled Board of Selectmen's meeting on May 21, town leaders unanimously approved support of our legislative efforts and affirmed the Inter-Governmental Agreement established in 2007.

Working through any previous concerns over the proposed legislation

Mashpee selectmen support legislation protecting Wampanoag land rights

The Board of Selectmen is formally backing federal legislation that aims to end an ongoing legal challenge to the Mashpee Wampanoag Tribe's reservation, saying legal counsel for both governments have agreed to a town-proposed amendment to the bill.

Last month, the board announced its support of the bill, which was introduced in March by U.S. Rep. William Keating, D-Mass., that seeks to reaffirm a 2015 decision by the U.S Department of Interior to take 171 acres in Mashpee and 150 acres in Taunton of tribal reservation land into trust. The legislation would also create statutory safeguards to bar future litigation on the matter in federal court. U.S. Sen. Edward Markey, D-Mass., has introduced the same bill in the Senate.

In a letter issued to the Sen-

ate Indian Affairs Committee and the House Natural Resources Committee, the town said it and the tribe have worked cooperatively to craft a minor proposed amendment to "further strengthen our agreement with each other."

The two parties exchanged letters in recent days about the proposed bill after the town initially expressed reservations about it not including language concerning the Intergovernmental Agreement.

"The establishment of the Mashpee Wampanoag reservation in 2015 was very long overdue, and we feel strongly that this legislation is needed to protect that reservation," the letter states.

Tribal leadership could not be reached for comment.

"Their attorneys have represented to our attorneys that tribal council is in agreement with this language," said Selectman Andrew Gottlieb.

The congressional action is intended as a fix to a 2009 Supreme Court decision, known as Carcieri v. Salazar, that ruled the secretary of the Interior Department could not take land into trust for tribes that were not under federal jurisdiction before 1934.

The status of the tribe's land was placed in limbo after Taunton neighbors of a proposed casino project successfully sued the Interior Department, and U.S District Court Judge William Young remanded the original 2015 decision to take the land into trust back to the federal agency for further deliberation.

Active Shooter/Hostile Event Roundtable Discussion Exercise Held at Government Center

The frequency of active shooter incidents has increased in recent years, and these incidents have affected numerous places where citizens congregate, such as schools, workplaces, places of worship, shopping malls, public meetings, and movie theaters. Unfortunately, these events highlight the need to reduce the risk of active shooter incidents while improving preparedness and strengthening ongoing efforts intended to prevent future occurrences.

The MWT Emergency Man-

agement Department in collaboration with the MWT Police Department hosted a multiagency emergency preparedness roundtable discussion in the early part of May. The roundtable discussion was based on hypothetical incidents designed to bring together tribal departments as well as IHS, local, county and state public safety agencies to discuss roles and responsibilities during an incident affecting the Tribe. As a result of the input and feedback gained from the participants, a plan will be established for the Tribe

to ensure preparedness and readiness in the event of an incident of this magnitude.



Mashpee Wampanoag Community Development Corporation to Host Community Meeting on Sunday, June 10 at General Membership Meeting

The Mashpee Wampanoag Community Development Corporation (MWCDC) will host a community meeting on Sunday, June 10 at 2:00 p.m. at the Mashpee Wampanoag Tribe Community and Government Center in Mashpee. During the community meeting the MWCDC will provide an update on the Utility Corporation and several other Limited Liability Corporations that the Board is currently exploring.

According to the MWCDC bylaws the Corporation will hold at least two meetings annually open to the tribal community to gather input and feedback.

The MWTCDC Board of Directors includes President Mark Harding, Vice President Tara Collier, Treasurer Nancy Rose, Secretary Steven Peters, Winnie Johnson-Graham, Talia Landry, and Angela Shwom. The Corporation was organized to engage in activities that will promote the social welfare, economic security and community development of the Mashpee Wampanoag Tribe and its enrolled citizens that will enable the Tribe to be self-sufficient and to provide economic support for its tribal citizens.

Granite Telecommunications and the Yale Club of Cape Cod Support Wôpanâak Language Education on the Mashpee Wampanoag Reservation

The Wôpanâak Language Reclamation Project recently received a donation to help expand the offerings at its language immersion school.

Granite Telecommunications and the Yale Club of Cape Cod donated \$5,125 to the school operated by the WLRP and the Mashpee Wampanoag tribe since 2016.

"A great portion of the funding that they are donating is going to help us expand our current pre-K and K classrooms to offer reading and seating area for our first grade students," said Jennifer Weston, the Project Director of Mukayuhsak Weekuw, also known as The Children's House.

The funding will also be used to purchase new curriculum materials to accommodate their more advanced STEM, Language Arts, Cultural Studies and Geography content.

The Children's House, based in the Mashpee Wampanoag Tribe's Community and Government Center, is expanding enrollment from 20 to 25 students in the fall.

"The children receive six hours daily of Wôpanâak language immersion instruction and also some language during our afterschool program from 3:30 to 4:30 p.m.," Weston said.

The immersion school follows the traditional academic calendar and offers classes 180 days per year totaling more than 900 hours of language immersion for full-time students.

"Our kindergarten students, because they potentially could transition into other school systems, they do receive about an hour a day of English language arts instruction both for reading and for some math content and geography as well," Weston said.

The majority of the students are 3- and 4-year-olds and they are receiving all of their subject instruction predominantly in the Wôpanâak language.

Weston said the goal is retain current kindergarten students through



grades 3 or 4.


"We have some teachers who are preparing to continue their Montessori Elementary Education so that they become certified as lower elementary teachers," she said.

The Wôpanâak Language Reclamation Project is a nonprofit initiative of the Wampanoag Nation whose mission is to restore the Wôpanâak language back to the community as the principal means of expression.

"Our indigenous languages are critical in linking us to understanding our ancestors' homelands," Weston said. "They tell us about our ceremonies and our roles as good relatives to each other and to the lands and waters where we've survived for many thousands of years."

Weston said learning the language empowers children and gives them a positive sense of their native identity, "which is something that is really lacking in public school systems for the most part."

Opinion by Aunt Joan Avant Tavares: Don't You Dare! Mashpee Wampanoag's are Sovereign

Talk about making an elder ill to the core, the Town of Mashpee Selectman did a good job making many of us sick with their greedy tactics on the Mashpee Wampanoag Indigenous people who inherently have a right to this land. Yet you want us to just give it all to you to put more fences up, build larger complexes so there will no spaces for our relatives today or future generations. Our leaders have worked with you faithfully with decisions made and agreed upon by both governments. Now you want to open old wounds regarding the rights of our people. Since colonization we have endured repeated law violations regarding land, fishing rights, ancient paths, rivers, lakes and with indigenous spirituality unaccepted. Your elected Town Officials. It's very apparent you're hearts have never been in the right place to accept who we are, our values, beliefs, and concerns about the preservation of Mashpee. You don't care about preserving Mother Earth and her resources that gives us all energy for life.

In the 1970's we were faced with if we were a tribe conveying along negative legal arguments in the courts. It appears today again as elected officials you want to open a similar can of worms as the saying goes. Making non-natives, Cape Coder's and others to believe we are the culprits negating our tribal government responsibilities and not working with the Town of Mashpee for cohesive relationships. My best guess is you believe the same because all of a sudden you want to add new language to the proposed Federal Legislation you agreed upon in 208. Now you want it to include (1) Waive and release any and all claims, right, interests and/ or entitlements relating to real property located within the geographical boundaries of the f the Town of Mashpee and owned by the Town of Mashpee, its agencies, commissions and authorities. (2) Not apply for, nor consent to, trust status for, or otherwise exercise control over or limit access to, any real property owned by the Town of Mashpee, with exception of the parcels described in Exhibits A and B of the IGA; and (3) Not to construct or operate a casino conducting either Class 11 or Class 111 gaming authorized under IGRA within the Town. This is clearly criminal and discrimination. "Mashpee Indians-Tribe on Trial" again. Don't you Dare! Mashpee Wampanoag's are now Federally Recognized and a Sovereign Nation.

Our leaders have worked very hard with 208 legislation. Chairman Cedric Cromwell says In 208 we cooperatively entered into an IGA (Inter-Governmental Agreement) to allay fears that the tribe would bring a land claim against the Town and local land owners. In the decade that has passed since then, we have continued to honor every aspect of the commitments we made in that IGA-and nothing has changed since the introduction of legislation that would protect our reservation...there has been many productive outcomes of our relationship with the town. We have offered to help pay for road repairs due to storm, helped town officials expand shellfish propagation, improve water quality and protect the Mashpee shoreline. We provide mutual aide between our tribal police and town police; have secured funding to develop housing for elders and have made our tribal Government and Community Center available during storms for shelter to all Mashpee residents...as well as numerous other non-tribal public events".

We want to continue to strengthen our Wampanoag indigenous identity here in Mashpee the Land of the Wampanoags and keep it that way. Remember, too much of this land was stolen and seized from our ancestors. Now it's time for you to give back, not set up more laws and policies against us. Do your research and read the documents.

Emergency Management Department Tips to Prepare Community for 2018 Atlantic Hurricane Season

What you should know about Hurricanes;

- Know what to do before, during, and after a hurricane.
- Prepare before hurricane season starts. Atlantic hurricane season starts June 1.
- Create an emergency communication plan with your family before a hurricane.
- Have emergency supplies in place at home, at work, and in the car.
- Check your insurance coverage, damages caused by flooding are not covered under normal homeowner's insurance policies.
- Know our areas evacuation plans and evacuation routes and how to receive alerts from the MWT Emergency Alert Notification System.
- Listen to local officials and MWT Emergency Response Personnel.

Make A Plan for Your Family

The Mashpee Wampanoag Tribe Emergency Management Department encourages our Tribal community to make a plan today. Your family may not be together if a disaster strikes, so it is important to know which types of disasters could impact our area. Know how you'll contact one another and reconnect if separated. Establish a family meeting place that's familiar and easy to find. Please reach out to the **Emergency Management Department** for assistance with putting together your family emergency plan, see steps below with Questions and Answers to assist in the process.

Step 1: Put together a plan by discussing these 4 questions with your family, friends, or household to start your emergency plan.

Q. - How will I receive emergency alerts and warnings?

A.- Provide your contact information to the Emergency Management Department in order to receive alerts and warnings through, phone, email and text.

Q. - What is my shelter plan?
A. - On Cape Cod the majority of residents in our community utilize the Barnstable County Regional Sheltering System, there is also the option to shelter in place and at times the C & G Center could be utilized. Also, please feel free to reach out to the Emergency Management Department for specific details and shelter information.

Q.- What is my evacuation route?
A.- Tribal members residing on Cape
Cod would utilize the Cape Cod
Emergency Traffic Plan for evacuations. Please contact the Emergency
Management Department for specific
information and to be added to the
evacuation assistance list.

What is my family/household communication plan?

Step 2: Consider specific needs in your household.

As you prepare your plan tailor your plans and supplies to your specific daily living needs and responsibilities. Discuss your needs and responsibilities and how people in your network can assist each other with communication, care of children, business, pets, or specific needs like the operation of durable medical equipment. Create your own personal network for specific areas where you need assistance. Keep in mind some these factors when developing your plan:

- Different ages of members within your household
- Responsibilities for assisting others
 - Locations frequented
 - · Dietary needs
- Medical needs including prescriptions and equipment
- Disabilities or access and functional needs including devices and equipment

- Languages spoken
- Cultural and religious considerations
- Pets or service animals
- Households with school-aged children

Step 3: Fill out a Family Emergency Plan

Download and fill out a family emergency plan or use them as a guide to create your own.
